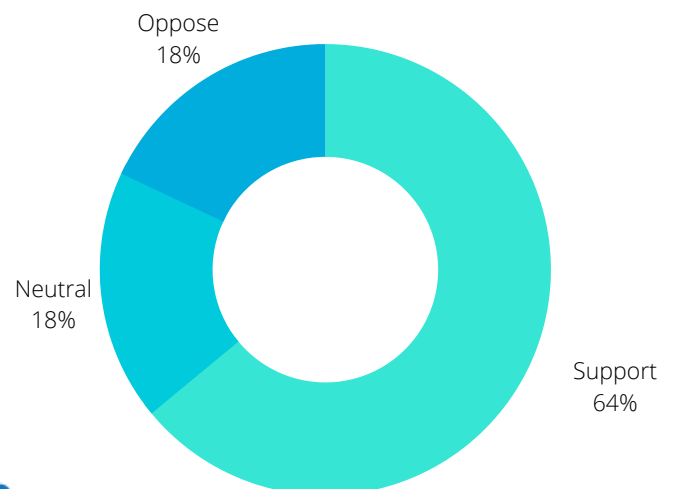

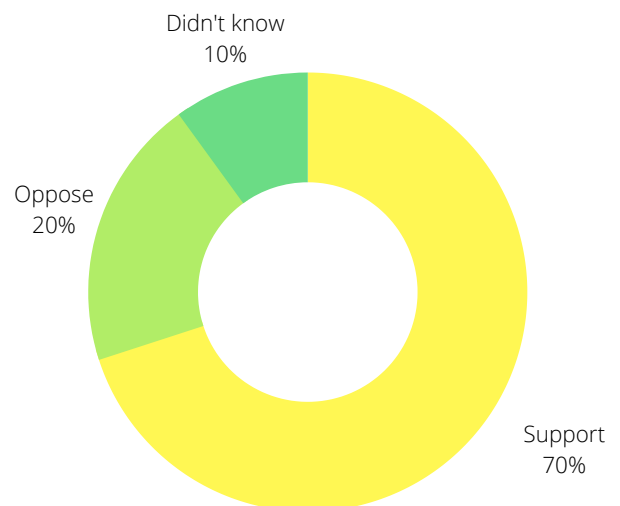
Nevada voters strongly support a shift to 100% clean energy...

When asked about a range of energy sources, 77% of Nevada voters said that the state should be using more solar energy. That compares to just 26% who say the same thing about natural gas and just 6% who say that the state should be using more coal.



Voters overwhelmingly support “a plan to require Nevada utilities to get 100% of their electricity from clean energy like solar by the year 2040” by a staggering 73% to 20% margin.

Voters also strongly support regulations to place a limit on total carbon emissions in Nevada including emissions from power plants, factories, and transportation fuels that would decline over time, reaching net zero emissions by 2050 by 70% to 20%.

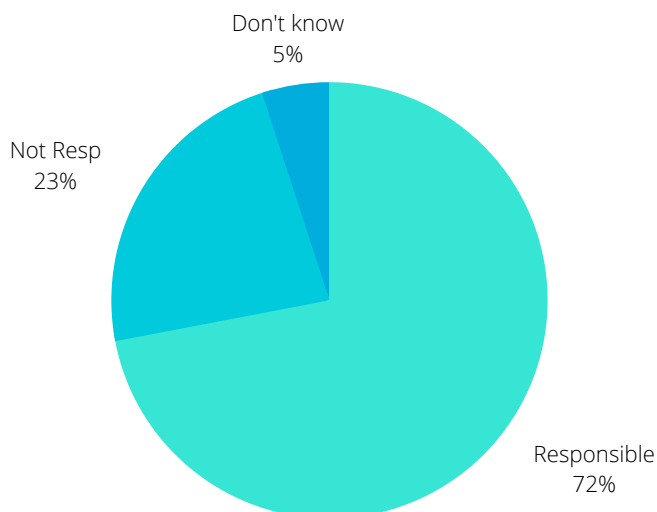

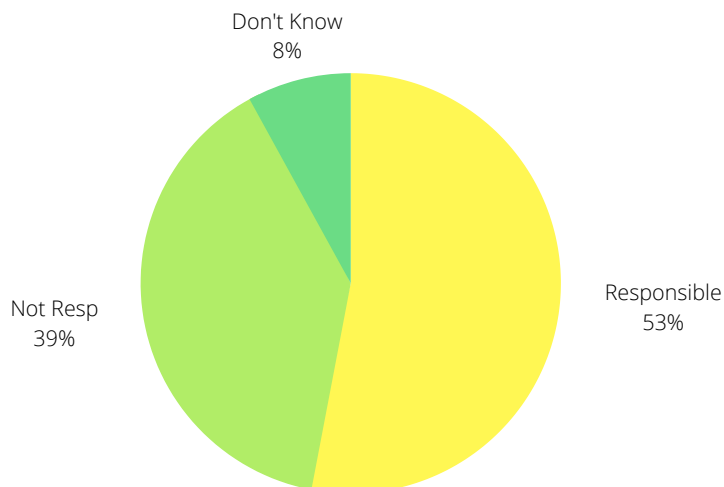

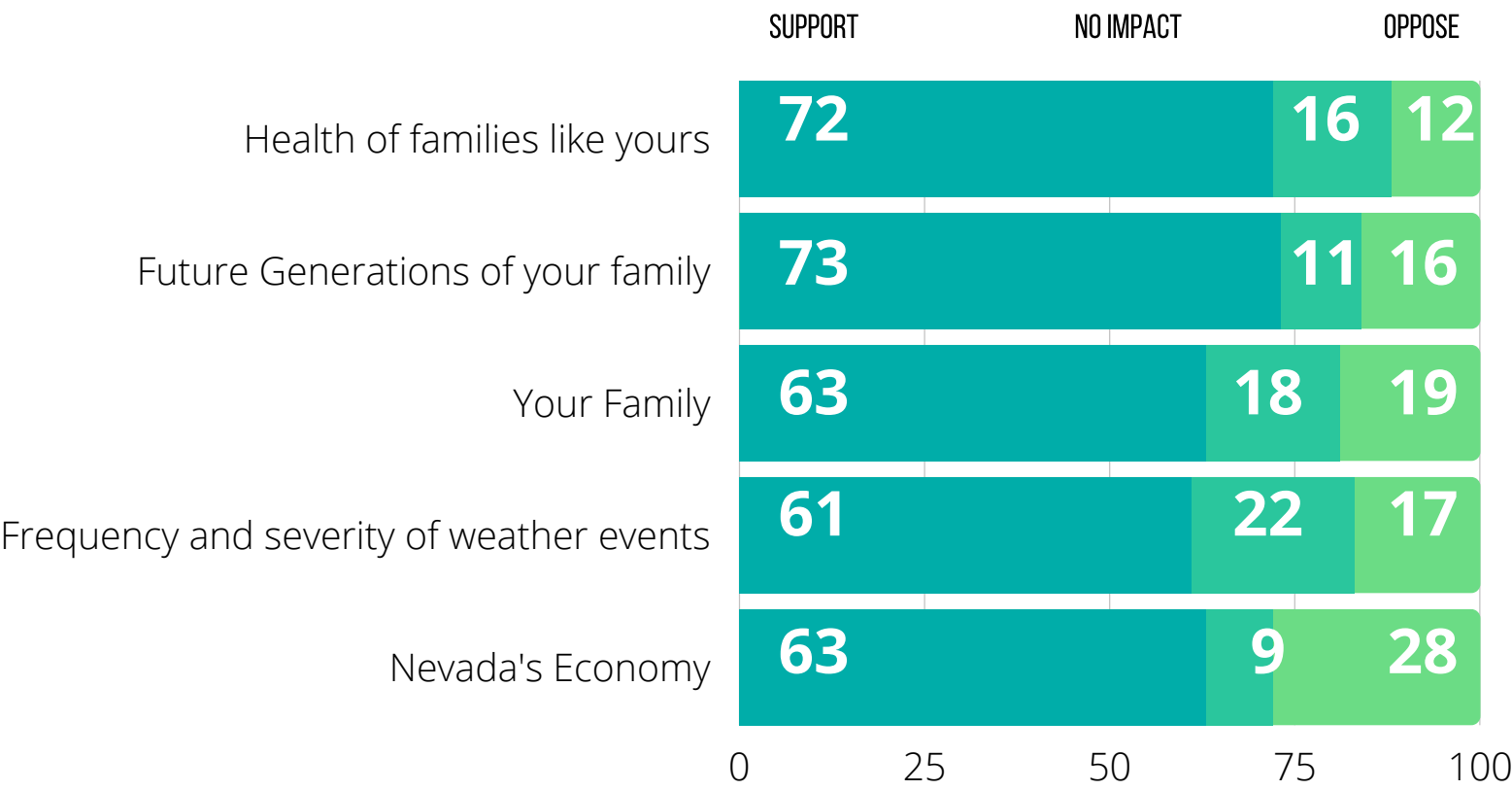

WHY NEVADANS SUPPORT TAKING ACTION ON CLIMATE CHANGE

Nevada voters' support is driven by an overwhelming belief that taking action would have a positive effect on families, harmful weather events, and our economy.



Over 70% of Nevada voters agree with the following statements:

About this poll: Global Strategy Group conducted a multi-channel survey from August 21st to September 7th, 2020 among 801 registered voters in Nevada. Respondents were surveyed via online panels or phones. Care has been taken to ensure the political, geographical, and demographic divisions of the population of registered voters are properly represented.
